This is **Addendum No. 3** to the MBTA's Request for Qualifications/Responses listed above (the "RFQ/P"). Addendum No. 1 and Addendum No. 2 were both posted on <a href="www.mbtarealty.com">www.mbtarealty.com</a> and distributed.

This Addendum No. 3 clarifies certain matters in the RFQ/P.

This Addendum No. 3 is hereby incorporated into the RFQ/P and supersedes any information to the contrary contained in the RFQ/P. All other terms and conditions of the RFQ/P remain in effect as set forth therein unless previously modified.

 Clarification regarding answers in Addendum No. 2 regarding Affiliates and Non-Licensee Carriers (bus carriers that are working with an Applicant but are not owned or controlled by the Applicants as Affiliates are).

Clarification: In addition to filling out the form for Affiliates in the Application both Affiliates and Non-Licensee Carriers will *at the time of execution of the Licenses* be

required to certify to MBTA as set forth below. The License, which must be executed by the Licensee, will be in the form substantially the same as the copy attached hereto. Section 14 therein discusses this matter in more detail. Non-Licensee Carriers will be required to show the items listed on <a href="Attachment A">Attachment A</a> hereto to certify that they have a valid and effective license and an adequate safety record; insurance certificates complying with the License; an acknowledgement that it is bound by the provisions of the License for users of Gates or other Licenses Spaces under that License and an acknowledgement satisfactory to MBTA in its sole discretion that all provisions of the RFQ/P and License(s) awarded to the Applicant are also binding on the Non-Licensee Carriers except for any expectations in the License; and other operational, safety or financial matters MBTA may request. All items and information required will be similar to those required from Applicants listed on Attachment A hereof.

- Correction: The date of the RFQ/P in Certification 1 of the Application is recited incorrectly as "\_\_\_\_\_, 2024," and is hereby changed to read: "June 25, 2025." Applicants may make that edit in pen on their copy of the Application they will submit but are not required to do so.
- 3. The License that awarded Applicants will be required to sign will be substantially in the form attached hereto as <u>Attachment B</u>.

NOTE: By Addendum No. 1 to the RFQ/P, the submission date for Applications by Applicants to MBTA was extended to August 14, 2025.
